## Pricing (post-trial, in order to continue to use LYNQ MES)

LYNQ is licensed by named resource. Your license supports unlimited users and unlimited terminals. A named resource license is required for any manufacturing employee, machine or work centre that you wish to track their effectiveness. A user is a management or administrative employee that is not directly involved in the production process. A terminal is a mobile or tablet device that is used for data collection and/or management purposes. Terminals may be used by an individual or shared between a group of workers.

LYNQ can be deployed on premise or in a private cloud. You may purchase the software only (perpetual or subscription). Perpetual - provides rights to use the software, meaning you own the licenses and can continue to use the software after the term of the agreement. To keep your software up to date and supported, you are required to pay Annual Maintenance and Support Fees charged at 20% of the software list price.

Subscription - Provides non-perpetual rights to use the software, meaning you can use the software only during the term of the agreement secured by periodic payments. This model lowers your initial licensing costs and provides the flexibility to increase or decrease the number of resources with each subscription.
